Achievements and Performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.

Before lockdown on 15th March, we held our weekly exercise sessions in Woking Leisure Centre
most Saturday afternoons. This allowed members to exercise in a supportive environment with
trainers on hand to run through the warm up, direct and support appropriate exercise and warm
down at the end of the session. After exercise, some members took the opportunity to socialise
at the Centre or a local public house.





- During this time, we also held aqua-aerobics sessions at Woking Home's pool on Tuesday mornings, when the pool was available. Members, not just those attending the pool, socialised over lunch at a local golf club in the afternoon.
- Since March, we have been unable to meet up in physically. As an alternative, we have been running Zoom sessions led by our stroke rehabilitation trained instructor for exercise and socialisation.
- When not able to meet up physically the Trustees kept in touch with our membership on a regular basis to see if they were in need of any extra help or support that we could provide.
- We continued to work with other charities to signpost and set up opportunities for our members.
- The social side of Woking Strokeability is as important as the exercise. However since lockdown began, we have had to rely on Zoom, social media and phone calls to maintain contact with our members. The only event we were able to organise was our Christmas lunch at the Cricketers, Horsell Birch in January.

Financial Review

Review of the charity's financial position at the end of the period

Total income: £9,264 (£16,857)

Members' weekly fees / annual membership: £2,189 (£4,555)*

External donations: £5,527 (£3,944)*
Social (trips & meals): £675 (£3,393)*

- We were able to use both the pool and leisure centre, and collect weekly fees until the middle of March. When lockdown started, we changed to running virtual sessions over Zoom that we have been able to run free of charge to our members.
- We have not been able to hold any collections or fundraising events this year. Fortunately, it has been a good year for donations from external sources. External donations include funding during the pandemic from the Community Foundation Surrey (£1,300), Talbot Underwriting (£1,000), St. James Place (£1,000) and Woking Borough Council (£500). Relatives of our Trustees donated / raised £1,300 and the Daisy Tuffin Flower Club donated £300. In addition, we had a number of smaller donations via Virgin Giving and PayPal.

Office costs that were higher this year and can be broken down by





- Charity running costs £699 this includes Public Liability and Trustees Indemnity insurances, Stroke Association affiliation, website maintenance, Zoom licences, DBS checks and training
- Materials purchased £1,189 sweatshirts and polo shirts for members and trainers;
 bender balls, cameras and microphones for Zoom exercise sessions; disability equipment for several members.
- Other £477 Christmas gifts for trainers and volunteers, birthday voucher for our trainer, flowers etc. for members when ill or hospitalised.
- At the end of the financial year we had a bank balance of £17,013
- Woking Strokeability only reimburses Trustees, volunteers, Officers, carers and beneficiaries for reasonable expenses, which were wholly, necessarily and exclusively incurred in connection with its operation.
- To ensure that accounts are kept complete and up to date the Chairman or Trustees can request a review of accounts at any time without notice. The Treasurer is responsible for giving full access to all paperwork and accounts within two weeks of the request.

- The principal risk is the loss of suitable facilities for both aerobics and aqua-aerobics. This risk was mitigated by running virtual rehabilitation sessions over Zoom.
- An unexpected risk was that, during lockdowns we are unable to hold fund raising events or collections. This risk was mitigated by a focus on raising funds through external donations.
